- a. Clause 3.3 under heading Project Appraisal Committee the Word EC has been substituted with PAC.
 - b. Sub clause 5.1 (vii) "*OGMCs would not be eligible for this financial assistance*" under sub heading Eligibility criteria for a pipeline connectivity has been omitted.
 - c. All other stipulation of the existing scheme guidelines issued vide OM No. L-16020/12/2022-GP-1-Paft(1)(E-49191) dated 26th June,2024 will remain same.
